

ADDENDUM TO EDUCATIONAL TOUR OPERATOR AGREEMENT

Under Section 2 – Responsibilities of the Educational Tour Operator

Surveys to be conducted occasionally to maintain compliance requirement to Canadian law and International Law.

2.11 The Educational Tour Operator is responsible for any subagent code of conduct, contracting and disclosure of all sub agents' contracts and processes that will work directly and/or indirectly with the
